

He suggests that Scalia displays such a keen interest in defending federalism that he sometimes departs from text and tradition, and reveals that he has disagreed with other justices most often in decisions involving the meaning of the First Amendments establishment clause. He also analyzes Scalias positions on the commerce clause and habeas corpus clause of Article I, the take care clause of Article II, the criminal procedural provisions of Amendments Four through Eight, protection of state sovereign immunity in the Eleventh Amendment, and Congresss enforcement power under Section 5 of the Fourteenth Amendment. The first book to fully articulate the contours of Scalias constitutional philosophy and jurisprudence, Rossums insightful study ultimately depicts Scalia as a principled, consistent,...
